ORGANIZING CLUB

Motoclub Maranello a.s.d, headquarters in Tazio Nuvolari n° 27 41053 Maranello (MO), www.motoclubmaranello.it, info@motoclubmaranello.it, organizes from 5 to 6 September 2020 the 1st edition of "ON THE ROAD" Maranello Mugello Maranello.

EVENT DETAILS AND ROUTE

The "ON THE ROAD" is a non-competitive event. This will take place in open **traffic areas**, so all participants must respect the Italian road laws. The route is around 650km, divided in 2 stages, passing through areas of interest for motorcycles fans and great landscapes with normal paths and unpaved areas (white roads).

All the participants **MUST** respect the actual road laws in any situation. The route or the total amount of km could change in case of unpredicted circumstances.

MOTORCYCLES and ADMITTED DRIVERS

The motorcycles that can take part to the "ON THE ROAD" Maranello Mugello Maranello events needs to be in conformity with road laws. During the preliminary operations the participants which Bike will be considered as non-compliant to the registered one (you are able to change it until 31st August) and/ or that doesn't apply to the road laws it will not take part to the event and no money will be refunded for this reason.

To keep the event as safest is mandatory to wear technical clothing such as bike boots, guards and approved helmet. At the starting grid, each participants who will not guarantee is provided with the above materials will not be allowed to take part of the event.

Quad, Scooter, specific enduro bikes and Sidecar are not admitted.

Driving license with ongoing validity is a mandatory request to be admitted to the event plus a health certificate. In addition is mandatory to have a valid subscription to the Italian Federazione Motociclistica (FMI), which can be arranged from the organisational team in case of need (please raise the request on your event registration so the organizing team can provide this to you). No passenger are allowed.

REGISTRATION FEE

€ 210,00 to participate at this two day event and already possess a MEMBERSHIP of F.M.I. card

€ 250,00 to participate at both events days but F.M.I MEMEBERSHIP to be arranged by the organisation team

The price includes: GPS details, assistance during the itinerary, FMI insurance, first aid assistance, identification bracelet, access to the dinner to celebrate the conclusion of step one, event gadget. The price does not include: mandatory FMI subscription, hotel accommodation, fuel, lunches, vehicle rescue with different transportation than the one provided by the event organisation and all what is not specifically included in the "the price includes" section.

The payment of the participation fee follow the following process: during your registration you must pay a deposit of 120€ and the rest of the amount (of 90€ or 130€) will need to be placed within 30th July 2020. If no deposit confirmation appears within a week from the event registration this will not be confirmed and the registration without a proof of the second payment will be considered as cancelled.

MEETING AND PRELIMINARY OPERATION

Preliminary operation, such as bikes and documents check, will take place Friday 4th September 2020 in the parking area of the "Museo FERRARI", Via Dino Ferrari 43- 41053 Maranello (MO), from 4 pm to 8 pm. We will verify each bike and hand out all the documentation. This is going to be the same **LOCATION FOR BRIEFING AND DEPARTURE** as well. The event briefing will take place Saturday 5th September at 08.30 am

DEPARTURES

The departure will take place Saturday 5th September 2020 at 9am, before this you will also receive the check steps.

The bikes will leave in group of 3 riders each minute, depending on your registration number, and for those who might arrive late they will leave at the end of the queue.

The event organization might decide to anticipate or postpone the departure for any inconvenience or unpredicted situation.

CHECK POINTS

During the event there will be some check points to verify that all the bikes are passing through the correct path.

The check points length and the departure times set will let the participants to travel keeping a speed allowance that is in line with the road regulations.

PENALTIES

Penalties that the participant could incur in are the following; a. Non-compliance with the road law (disqualification) b. Noncompliance with the regulation (disqualification) c. Non-compliance clothing during all the event time (disqualification) d. Absence during the event briefing, non-including some specific cases that needs to be communicated immediately or for any serious circumstances (ps. Is not allowed to travel the second day and arrive directly at the end of the stage using asphalt).

DAILY PROGRAMME

GPS track will be given 3 days prior to the departure via email. **All participants must show up at the departure line with the track already on their GPS system.** It is allowed to have one GPS per group.

CLOSED AREAS

In the departure and arrival places you will find some unguarded rest areas that will be reported with barriers or suggested by the event staff onsite. The organization is not responsible for any thefts or any damage.

MECHANICAL ASSISTANCE

The assistance vehicle, after the event, will only provide technical or mechanical support that will not include massive need of specific material or work. For any complex assistance that might require the use of materials or replacements, the participant will have to provide them personally. In case of a stuck vehicle our assistance will help, whenever possible, to bring it to the first asphalted street in order for the tow truck to intervene (provided by FMI association).

OBJECTIONS AND REGULATION CHANGES

Everything not included in this regulation document and connected to the attendance of the event **"ON THE ROAD" Maranello Mugello Maranello** will be taken in account from the Motoclub Executive members (DMC = Direttivo del MotoClub) which will react to any participant objections or criticism with unappealable decision on the personal interpretation of the above document.

GENAL RULES

All participants registering to the event implicitly confirm they are aware of the event regulation and they will stick to it during the overall event period. For any objections or wrong interpretation of the regulation the Motoclub Executive team will be the entity taking steps and deciding consequences. All participants that sign the registration document waive any responsibilities from the organization, all third party suppliers and any other person involved for any damage or inconvenience to themselves, third parties or objects. This includes the arrival and departure site or any other areas during the path. By participating at the event you confirm you give up any ideas of authority complaint.

N.B.: The above regulation could be updated in which case it will be communicated during the preliminary operations.

CANCELLATION POLICY

In case of cancellation the 50% of the registration fee will be returned **ONLY** if informed via registered email or Certificated poste before 1st September 2020 at the following **address** Motoclub Maranello via Tazio Nuvolari n° 27 - 41053 Maranello (MO) or **email** MC08656@peg.federmoto.it. All cancellations after that day won't be able to receive any refund even if only the deposit amount has been paid (€ 120,00). **In case of the event cancellation for any inconvenient or unpredicted situation the event fee will not be refunded.**
